2. EMD of Rs. 2,11,930(Rs.Two lakh eleven thousand nine hundred thirty rupees only) to be paid through any of the following five modes only. I) Credit card II) Debit Card III) NEFT (National electronic fund transfer) IV) Net Banking. Bids will be evaluated only on confirmation of receipt of the payment (EMD) in the GoK's central pooling a/c. The EMD of unsuccessful bidders will be refunded and after execution of agreement of the successful bidders and while executing the agreement 5% FSD to be deposit and after completion of the supply the FSD will be released.
